Interests and fields of work:

My work has mainly been concerned with poverty, inequality, labour, human resources and employment in low and medium income countries, especially in South and Southeast Asia and in Latin America. This has included analysis of labour market outcomes and their relationship to economic development; the impact on poverty and employment of state policies and of the behaviour of other social actors; labour market patterns as aspects of social and economic inequality; the development of training systems and policies; the notion of social exclusion and its application in low income settings; studies of interactions between economic and demographic behaviour; analysis of globalization and its impact on social objectives; and work on economic and social systems and models, both theoretical and empirical. I have also worked on labour market issues in industrialized countries, and have managed technical support programmes for governments, workers and employers in Latin America. My recent work includes studies of rural development in Bihar, India; a comparison of the development paths of India and Brazil, with particular attention to patterns of inequality; and a study of the pattern of employment and development in Northeast Brazil.
